ORDINANCE NO. 6031

AN ORDINANCE AMENDING FAIRBANKS GENERAL CODE SECTION 2-491 TO CLARIFY AND UPDATE THE CITY'S ADMINISTRATIVE DEPARTMENTS

WHEREAS, City Charter Section 4.3 provides that administrative departments will be established by ordinance and that the head of each department will be a director who shall be an officer of the city; and

WHEREAS, Fairbanks General Code Sec. 2-491 establishes the administrative departments of the city and the head of each department; and

WHEREAS, changes to the city's management structure have occurred since this section was last updated; and

WHEREAS, changes are needed to reflect the current management structure of the city.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

SECTION 1. That Fairbanks General Code Section 2-491(a) is amended as follows [new text in **underlined/bold** font; deleted text in **strikethrough** font]:

RESOLUTION NO. 4761

A RESOLUTION TO EXTEND THE CITY'S CONTRACT WITH KOHLER, SCHMITT & HUTCHISON FOR AUDITING SERVICES

WHEREAS, FGC Section 2.626(c) provides that the contract with the certified public accountants for the City's independent audit will be for a period not to exceed five years and that a new request for proposals (RFP) be issued during the final year of the contract; and

WHEREAS, the current audit contract with Kohler, Schmitt & Hutchison is set to expire at the end of 2016; and


WHEREAS, the City has not been able to issue the December 31, 2015, audit due to delays in receiving the required Alaska Public Employees' Retirement System (PERS) information from the State of Alaska; and

WHEREAS, in order to maintain the independence of the current audit contractor, the City cannot issue a request for proposals for audit services for upcoming years until the December 31, 2015, audit is complete.

NOW, THEREFORE, BE IT RESOLVED by the Fairbanks City Council that the current contract between the City and Kohler, Schmitt & Hutchison for auditing services is hereby extended until such time as the City has completed the RFP process and awarded the contract for auditing services pursuant to that RFP.

The following is a summary of recent changes to construction contracts. City Code Sec. 54-102 states "Any change order issued under this subsection which exceeds \$25,000 shall be reasonably noticed to the city council by the administering authority."

- Hamilton Acres Improvements project increased from \$636,727.00 to \$759,679.49
 - O Addition of storm drain inlets and pipe to improve drainage, manhole adjustments, and restoration of riverbank where new a storm drain outfall was installed
- Rickert Subdivision Improvements project increased from \$1,999,760 to \$2,124,760
 - o Additional paving and storm drain work for 18th Avenue (approximately 700 feet)
- Gateway Subdivision Improvements project increased from \$2,316,452 to \$2,485,452
 - Additional paving and storm drain work for Ladd Avenue and Judd Street (approximately 800 feet)

CALL TO ORDER

Chair Eberhart asked Mr. Kelvin Lee to read aloud the mission statement of the Fairbanks Diversity Council (FDC).

APPROVAL OF AGENDA

Ms. Richards, seconded by Ms. Rogers, moved to APPROVE the Agenda.

Ms. Richards asked for a brief recess for refreshments to celebrate Mayor Eberhart's recent birthday.

Chair Eberhart requested that Item (c) of Unfinished Business and Items (a) and (b) of FDC Committee Reports be POSTPONED to the next Regular Meeting.

Ms. Kan requested to add a new item titled, "International Friendship Day Discussion" under New Business.

Ms. Bailey requested that the discussion on SB 91 be moved up to come after the Approval of the Agenda.

Chair Eberhart called for objection to the changes to the Agenda and to APPROVING the Agenda, as Amended, and, hearing none, so ORDERED.

Chair Eberhart called for a brief recess. The meeting reconvened at 5:55 p.m.

DIVERSITY TOPIC OF THE MONTH

a) SB 91 Discussion – Senator Coghill's Office Representatives

State Senator John Coghill, Aide Jordan Shilling, and Alaska Criminal Justice Commissioner Brenda Stanfill spoke to the development of SB 91 and to the changes the bill would bring to law enforcement, the courts, and corrections. They discussed recidivism and the changes that SB 91 will make to pretrial processes, sentencing, post-conviction supervision, driver's licenses and food stamp eligibility. Sen. Coghill, Mr. Shilling and Ms. Stanfill answered questions from FDC members.

CITIZENS COMMENTS (Limited to 3 Minutes)

Nicole Johnson Snipes, 1304 24th Avenue, Fairbanks – Ms. Johnson Snipes stated that the Office of Children's Services (OCS) has taken her granddaughter and that she only has visitation with the child currently. She stated that her granddaughter is half Black and half Native Alaskan. She stated that she was told that "the Black side doesn't really matter."

Shirley Snipes, 1201 Kellum Street, Fairbanks – Ms. Snipes stated that the Tribal Committee has given Nicole permission to raise the child, but that OCS will not allow Nicole to have custody of the child unless she disowns her daughter Sherena, the child's birth mother.

Ms. Bailey and Ms. Lee gave some suggestions to the ladies and stated that they would like to speak more with them after the meeting. Ms. Lee requested a brief recess.

Chair Eberhart called for a brief recess at 7:17 p.m. The meeting reconvened at 7:29 p.m.

Tyrone Burkhead, 2113 Gillam Way, #8, Fairbanks – Mr. Burkhead commented that the City of Fairbanks refuses to observe Dr. Martin Luther King's birthday as a holiday. He stated that the City only recognizes it as a day of service. He stated that the federal government, the borough, the state, the school district, the City of North Pole, and the University of Alaska all recognize the day as a holiday and commented that the City of Fairbanks should do the same.

Chair Eberhart stated that he has tried to get Dr. King's birthday observed as a City holiday, and added that there would be a cost to the City in doing so. He stated that the holiday would have to be negotiated into all the bargaining agreements between the City and various unions. He indicated that he would continue efforts to make the day a City holiday.

William Biederman, Eagle, Alaska – Mr. Biederman stated that he is a resident of the halfway house. He stated that he was threatened earlier in the day with being sent back to prison because he missed the van to the Center. He commented that he is "walking taxpayer dollars." He spoke to the importance of small acts of kindness and encouraged everyone to be friendly and engage in conversation with other members of the community.

Marilyn Russell, 221 Well Street, Fairbanks – Ms. Russell spoke to the importance of getting to know other cultures. She stated she heard about a First Nation camp for new teachers in Alaska that teaches Alaska culture; she spoke in support of such educational opportunities.

Hearing no more requests for testimony, Chair Eberhart declared Citizen's Comments closed.

Chair Eberhart requested that, due to time constraints, all remaining agenda items with the exception of the Approval of Previous Minutes and International Friendship Day Discussion be POSTPONED until the next Regular Meeting of the FDC. No members objected to the request.

Ms. Kan stated that the 30th Annual International Friendship Day event will take place on Saturday, October 15 at the Pioneer Park Centennial Center. She invited everyone to attend and celebrate the diversity in Fairbanks. She distributed a program from the previous year and spoke to the performances and activities that make up the event. She stated that display booths are free of charge and encouraged the FDC to participate by hosting a table.

Chair Eberhart stated that the FDC now has a banner and bookmarks that can be used for the event. He stated that members can discuss more details about participating in the event at the September meeting.

- Ms. Kan stated that it was nice to have Senator Coghill attend the meeting to discuss SB 91.
- Ms. Rogers stated that the FDC has been in existence for about two years; she commented that the group offers an open door for people to come to for help. She stated that she is glad there are FDC members with some expertise in certain areas who can offer some help to the Snipes family.
