ORDINANCE NO. 5963

**AN ORDINANCE AMENDING FGC SECTION 2-396
REGARDING THE FACT FINDING COMMISSION**

WHEREAS, on February 24, 1992, the Fairbanks City Council established a Fact Finding Commission by adopting Ordinance No. 5038; and

WHEREAS, the purpose of the Commission is to assist the City Council in the investigation, collection, assessment and analysis of any issue referred to the Commission where facts are in dispute or are unknown; and

WHEREAS, the Fact Finding Commission has not been called upon to assist the City Council in many years, and FGC Section 2-396 has not been amended since it was adopted in 1992; and

WHEREAS, the Commission is still considered active, so members and terms must be tracked and maintained on a regular basis; and

WHEREAS, it would be beneficial to lengthen members' terms from two years to five years and eliminate the two alternate positions so that appointments will be needed less frequently and the City will save money on advertising; and

WHEREAS, it appears that the Commission may be better served by a cross-section of members from both inside and outside the city limits, and it has proven difficult to fill vacancies when all positions are limited to City residents.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

SECTION 1. Fairbanks General Code Section 2-396 is hereby amended as follows [new text in **underlined bold** font; deleted text in ~~strikethrough~~ font]:

Sec. 2-396. – ~~Created~~Composition.

- (a) There ~~is created~~ a fact finding commission **shall** consisting of five members, serving without compensation, ~~to be~~ appointed by the mayor **and** subject to confirmation by the city council. **At least three** The members of the commission shall be residents of the city. The ~~membership of the~~ commission shall consist of two members who are ~~recognized~~ **experienced** in the fields of law or judicial enforcement and three members from the public at large. The ~~initial chairman and vice-chairman~~ shall be ~~appointed~~ **elected** by **and from the fact finding commission members**, the mayor subject to confirmation by the city council. Of the five members appointed, one shall be appointed to a term expiring December 31, 1992; two shall be appointed to a term expiring December 31, 1993; and two shall be appointed to a term expiring December 31, 1994; thereafter,

Appointments shall be for ~~two~~**five** years, except when an interim appointment is necessary to complete the term of a member who resigns, dies or is otherwise removed while in office.

~~(b) The mayor shall also appoint, subject to city council confirmation, two alternates who at the election of the chairman shall sit in the place of any absent regular or otherwise assist the commission as directed by the chairman. One alternate shall be a member who is recognized in the field of law or judicial enforcement, and one alternate shall be a member of the public at large. Of the two alternates, one shall be appointed to a term expiring December 31, 1993, and one shall be appointed to a term expiring December 31, 1994; thereafter, appointments shall be for three years.~~

SECTION 2. That the effective date of this Ordinance shall be the ____ day of January 2015.

**A RESOLUTION IN SUPPORT OF THE FAIRBANKS METROPOLITAN

WHEREAS, FMATS is the Metropolitan Planning Organization (MPO) for the Fairbanks Urbanized area and therefore receives federal highway funds for transportation planning and projects that improve the infrastructure for city residents; and

WHEREAS, FMATS' federal transportation funds decreased by 30% in Federal Fiscal Year 2013; and

WHEREAS, FMATS' has not received state funds in the past two years and this has impaired the MPO's ability to meet pressing transportation needs in the metropolitan area; and

WHEREAS, FMATS will be unable to continue to improve the safety of its roads, prepare for economic opportunities, and preserve the existing road system without state support; and

WHEREAS, FMATS has many projects in the cue that are short-funded due to the decrease in federal transportation funding to MPOs;

NOW THEREFORE BE IT RESOLVED, that the Fairbanks City Council supports FMATS in their request for \$15 million from the State of Alaska for the development of projects in the approved Transportation Improvement Program (TIP).

BE IT FURTHER RESOLVED that copies of this resolution shall be sent to the Honorable Governor Bill Walker and the Interior Delegation.

Mayor Eberhart called for Public Testimony.

Bill Rogers, 408 Cushman Street, Fairbanks – Mr. Rogers stated that he is the owner of McCafferty’s Coffee House, directly adjacent to the distillery. He thanked the Council for their hard work and service. He stated that when the Borough’s zoning code was proposed to include distilleries in the central business district, he spoke against it. Mr. Rogers stated that he supports the approval of the liquor license due to the decline in activity on that block. He mentioned nearby businesses that have closed their doors or plan to shut down in the near future. He expressed faith in Mr. Levy’s ability to be a responsible business owner.

Hearing no more requests for public comment, **Mayor Eberhart** declared Public Testimony closed.

Mr. Matherly stated that he recently spoke to Mr. Levy. He encouraged the Council to approve the application for a new liquor license with the contingency that Mr. Levy must first obtain a Certificate of Occupancy from the City.

Mayor Eberhart called for Public Testimony.

Eureka McCrae, 643 Wainwright Road, Fairbanks – Ms. McCrae stated that she is the store manager for the University Safeway located at 3627 Airport Way. She explained that Safeway, Inc. holds the license for the Oaken Keg stores at the University Avenue and College Road locations. Ms. McCrae stated that Safeway, Inc. is currently a publically-traded company, but clarified that there is a pending transaction that would change the ownership of Safeway, Inc. to Albertson's Holdings, LLC, which will affect 1,000 stores nationwide. She stated that the new entity has not indicated that there will be any changes to the look of the Safeway stores or to the current management of the stores. Ms. McCrae explained that the transfer of ownership is somewhat of a formality in order to comply with the regulations of the Alaska Alcohol Beverage Control (ABC) Board. On behalf of Safeway, Inc. Ms. McCrae asked the Council to support the transfer.

My preference is that the six of you and I rotate attending the FNSB Assembly meetings so that we become more familiar with the FNSB government and vice versa. Accordingly, I suggest that the Clerk's Office slot each of us, including me, in for an equal period this year. If this is not desirable to you then I do not intend to nominate a single representative from among you. Instead, I will plan to attend and, if I am unable to attend a particular meeting, I will ask the Clerk's Office to try to arrange for one of you to attend in my place.

Once upon a time, the City apparently had seats on the assembly. Charter Section 13.11 is an interesting read. However, it was superseded by the passage of AS 29.20.060 which stated that members of a borough assembly may not be elected or appointed by and from the council of a city in the borough.

The Borough code provides for the appointment of "delegates" to the assembly from home rule cities and from the school board [see, FNSB Code Sections 2.08.050, 060, and 070]. Such delegates may sit with the assembly at all meetings and may participate in all deliberations but may not vote. Such delegates are also eligible for appointment by the presiding officer to assembly committees. A delegate may be either an elected official or an appointed official of the city they represent.

The Borough code simple states that a city may select a delegate to the assembly. There is no specific language in our code as to the process for appointing a delegate to the assembly. In my experience, this has been an ad hoc process. Absent, a specific procedure, the standard method for similar positions is – appointment by the mayor with the consent of the council.

Background

The Engineering Department issues Encroachment Permits for placement of utilities in the public right of way. Permits are issued for water, sewer, steam, electrical, telephone and other utility related purposes, above or below the right of way.

We are currently issuing a permit to ADOT for installation of a traffic signal electrical load center, to be used in conjunction with a traffic signal upgrade planned for the Airport Way and Barnette Street intersection this summer. The load center will be situated at the south terminus of West Barnette Street, just inside the access control fencing. The proposed facility consists of a typical gray electrical panel mounted on a post, with an electrical meter.

This notice is given pursuant to FGC Sec. 70-501, subsection (4). No Council action is required.

ENCROACHMENT PERMIT: Structure Permit No. E-15-01

This permit made and given this _____ day of January 2015 by the City of Fairbanks, a municipal corporation of the State of Alaska, with address of 800 Cushman Street, Fairbanks, Alaska 99701, as managing authority under A.S. 29.35.010, hereinafter referred to as "the City", and the Alaska Department of Transportation and Public Facilities, with address of 2301 Peger Road, Fairbanks, Alaska 99709 hereinafter referred to as "Permittee" in consideration of the stipulations and conditions hereinafter provided.

WITNESSETH:

The City hereby grants a permit to the Permittee for the maintenance and operation of facilities located within City Right of Way as hereinafter provided.

1. Permitted Structure: Electrical Load Center, including foundation and associated flat work, as shown on the attached exhibit 'A' incorporated herewith.
2. Permitted Area. A parcel of Right of Way as described by course and bearing situated within and coincident with the westerly right of way line of West Barnette Street, such that the south west corner of said parcel lies South 16° 00' 30 West 2.32 feet of the south East Corner of Parcel 'Z', Rickert Homestead, as Plat Number 81-101, Records of the Fairbanks Recording District, Fourth Judicial District, State of Alaska, containing an area of 122 square feet, as shown on attached Exhibit "A".
3. A permit fee is charged as follows, to be paid in full prior to issuance of this permit:
Basic Permit Fee: PERMIT FEE WAIVED.
4. Special Conditions
 - A. Facilities constructed under authority of this permit shall meet National, State and Local code requirements.
 - B. Facilities constructed under authority of this permit shall at all times be maintained in a safe condition, free of hazards.
5. Term and Termination. This Permit is given for a period of twenty (20) years from date of execution, below. After the initial term hereof, the City may, at its sole discretion and without cause and without notice, terminate this permit and any rights granted hereunder. In such event, Permittee shall immediately vacate and surrender the premises, leaving same in condition equal to that which existed prior to grant of this permit.

6. Tenancy Not Created. No real property interest is conveyed by this instrument.

7. Joint Use. To the extent practicable, the City will seek to avoid joint use of Facility corridors or sites issued under this permit. However, when such is unavoidable, the City will seek to avoid incompatible uses by notifying the Permittee in advance of the proposed joint use and soliciting input as to possible objections to the proposed joint use.

8. Permitted Activities. This permit is issued to allow and provide for general maintenance and operation of the permitted Facilities only. Any work that cannot be reasonably construed as general maintenance of the Facilities is not permitted under this permit but must be applied for and permitted separately.

9. Restoration and Standards. To the extent operation or maintenance activity by the Permittee under this permit materially disrupts the surface or subsurface condition of the permitted right of way, the Permittee shall be responsible to expeditiously restore, remove debris, repair and reconstruct the affected property to a condition that is equal to or better than the condition of the property prior to the activity, or as approved by the City Engineer. All such work to restore, repair and reconstruct the property shall comply with applicable construction standards of the City.

10. Insurance Required.

For purposes of this Encroachment Permit, the State of Alaska program of Self-Insurance is accepted in lieu of commercially obtained insurance.

11. Temporary Construction Permits. Upon demonstration of need, the City may, at the request of the Permittee, issue a temporary construction permit(s) for a larger access corridor or parcel when such is needed to accomplish work on the Facility or as may be necessary to meet OSHA standards for safety.

12. Access. Permittee is hereby granted immediate access to permitted area as may reasonably be necessary for construction, operation and maintenance of the Facility.

13. Testing and Inspection of the Work: As required by the City of Fairbanks Building Official. The Permittee shall be responsible for the costs thereof.

14. Utility Locates. Prior to implementing any construction and/or maintenance activity under this permit, the Permittee shall obtain locates and coordinate facility construction and maintenance with owners of any other existing public utilities also occupying space within the right of way corridor.

15. Management Authority. The City of Fairbanks is vested with management of the permitted Right of Way pursuant to Alaska Statutes 29.35.010.

16. Maintenance. Permittee shall at all times maintain the Facility in a safe condition, free from hazards or dangerous conditions.

17. Maintenance and Operation Costs. The entire cost of operating and maintaining or other activities associated with the operation of the permitted Facility, and other expenses incident thereto, are the sole responsibility of the Permittee, without limitation.

18. Penalties and Cancellation. In the event the terms of this permit are not fully adhered to, the City reserves the right to correct whatever violation has occurred and to bill the Permittee for actual costs plus a penalty of Five Hundred Dollars (\$500.00) per day for the duration of the period of the violation. Depending upon the nature of the violation, the City reserves the right to terminate and cancel this permit, in whole or in part, upon 90 days advance notice to the Permittee.

19. Laws To Be Obeyed. The Permittee shall keep fully informed of all Federal and State laws, all local laws, ordinances and regulations and all orders and decrees of bodies or tribunals having any jurisdiction or authority, which in any manner affect those engaged or employed by the Permittee, or which may affect the conduct of the work by the Permittee. The Permittee shall at all times observe and comply with all such laws, ordinances, regulations orders and decrees. The Permittee shall protect and indemnify the City form against any claim or liability arising from or based upon the violation of any such law, ordinance or regulation.

20. Assignment. This permit may not be assigned or otherwise conveyed except upon approval by the City in its sole discretion.

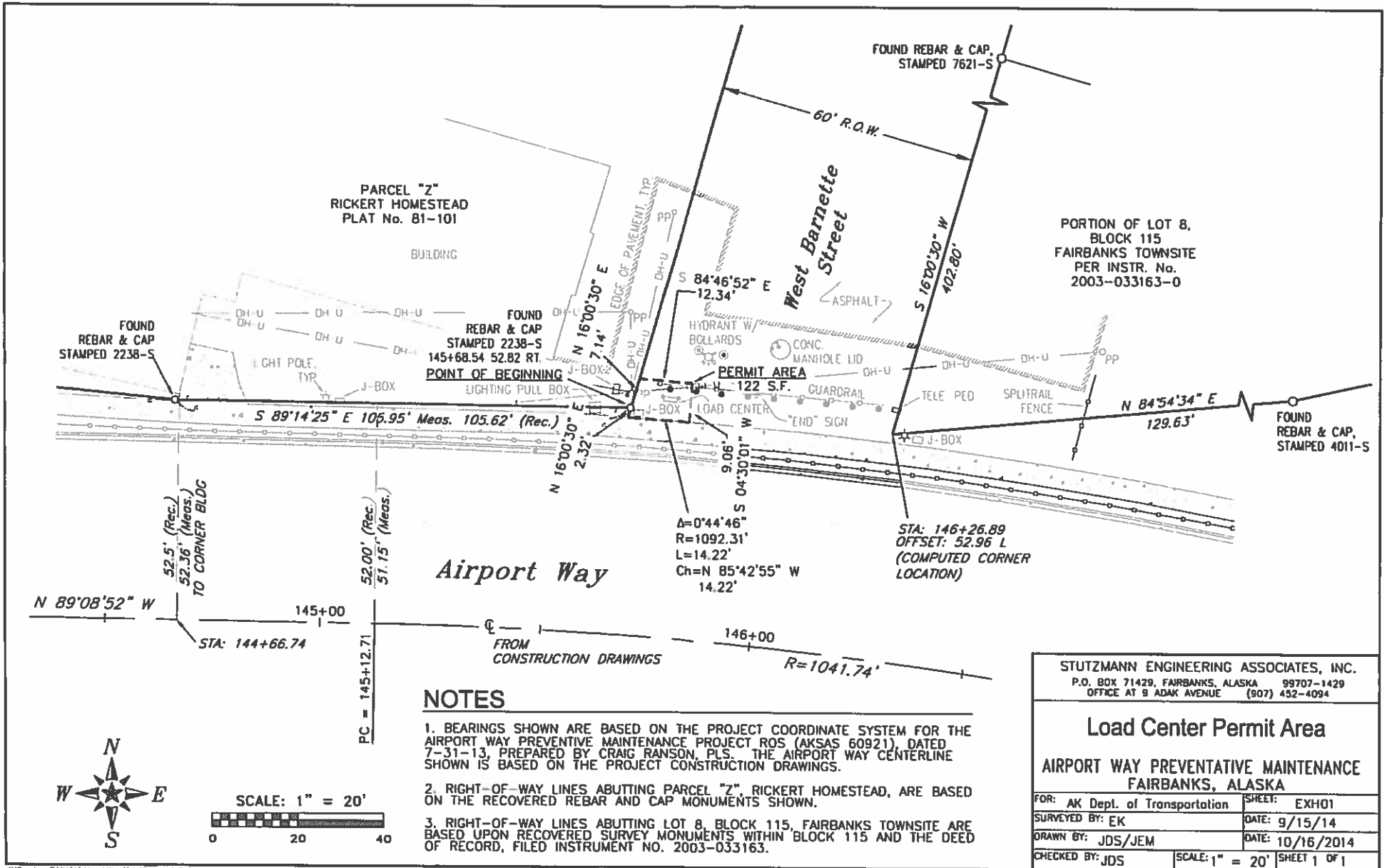

The **Clay Street Cemetery Commission** convened at 5:00 p.m. on the above date to conduct a Regular Meeting at the City Council Chambers, 800 Cushman Street, Fairbanks, Alaska, with Chair Bill Robertson presiding and with the following members in attendance:

APPROVAL OF PREVIOUS MINUTES

a) Regular Meeting Minutes of September 3, 2014.

Mr. Erickson, seconded by **Mr. Turney**, moved to APPROVE the Regular Meeting Minutes of September 3, 2014.

Chair Robertson called for objection and, hearing none, so ORDERED.

APPROVAL OF AGENDA

Chair Robertson requested that the following new items be added under New Business:

Item (e) – Draft Letter to Public Works Requesting Funding for Clay Street Cemetery
Item (f) – New Rotary Committee

No members objected to the proposed changes to the Agenda.

CITIZEN'S COMMENTS

Chair Robertson called for Public Testimony.

Rex Fisher – Mr. Fisher spoke to the \$10,000 contribution of Fort Knox and Pedro Gold Mines to the Commission for grave markers. He stated that he was not included when the donation was made and stated that he has identified many more Miners that did not receive markers with that funding. He stated that he would like to talk more about it under Open Agenda.

COMMUNICATIONS TO COMMISSION

a) Letter of Thanks to Festival Fairbanks

Members reviewed the draft and there were no objections to sending the letter.

UNFINISHED BUSINESS

- a) Commission Rules of Procedure Draft

Chair Robertson stated that since Mr. Pruhs is absent he would like to POSTPONE the item until the next meeting.

No members objected.

- b) Pending Placement Application – April Schumacher

Mr. Turney stated that he has not been able to make contact with Ms. Schumacher but that he would continue to try to reach her. He stated that a cross has also been added to one of the sites.

Chair Robertson stated that the items Ms. Schumacher placed were on the wrong gravesites.

NEW BUSINESS

- a) Navigation in the Cemetery

Chair Robertson indicated that discussion on how to navigate in the Cemetery will have to wait until the new kiosk is placed next spring. He stated that he met with Phil Sanders at the Cemetery and mapped out the exact location for the kiosk. He shared that Melissa Kellner from the FNSB Historic Preservation Commission was also at the Cemetery to determine the exact location for the new historic sign.

- b) Exhumation of Chief Nagita

Mr. Turney spoke to the exhumation of what was thought to be the body of Chief Nagita about four to five years ago before the Commission was formed. He stated that Nagita was mapped to be in plot 331 next to Frank Windquist, underneath the chokecherry tree. He stated that some claim that the body of August Anderson in plot 333 was exhumed instead. **Mr. Turney** stated that the exhumed body is supposedly reburied in a Nenana cemetery.

Mr. Erickson asked if anyone has formally asked about the remains of Chief Nagita.

Chair Robertson stated that the Commission needs to contact someone in Nenana and find out the location of the buried body. He requested that Mr. Turney send him the contact information for the individual in Nenana so that he could make contact.

Mr. Turney stated that the group of individuals that exhumed the body were from the university. He stated that the Ketzler family believes that the wrong body was exhumed.

Mr. Erickson cautioned that if indeed the wrong body was exhumed, there would likely be some legal issues.

Ms. Ripley asked why there is doubt that the wrong body was dug up.

Chair Robertson replied that if the map is accurate, the site that was exhumed was not correct.

Mr. Turney stated that he received a call from Ms. Ketzler, a relative of Chief Nagita, who informed him that the DNA of the body did not match. He stated that he feels that the Commission has an obligation to research the issue and straighten it out.

c) Written Statement for Unapproved Placements

Chair Robertson stated that the Commission come up with a standard, written statement for unapproved placements. He suggested that the City's legal department draft a template letter that could be used by the Commission in cases of items placed without permission.

Deputy Clerk Snider stated that she would speak with the City Attorney to see if a letter would be appropriate.

d) 2014 Hotel/Motel Discretionary Fund Grant Application

Chair Robertson stated that the first markers placed at Clay Street by the Commission were in 2011 with the funding from the gold mines. He stated that the 2012 and 2013 markers were funded with bed tax grant dollars. He commented that he is not certain how money he should request on behalf of the Commission in the 2014 application.

e) Draft Letter to Public Works Requesting Funding for Clay Street Cemetery

Chair Robertson stated that 34 markers were placed over the summer on the bases that the Commission had already acquired. He related his plan to request funding for more bases through the City's Public Works Department and distributed a draft letter to Commissioners. He stated that there are 50 new granite markers stored in the shed at the Cemetery that will need bases. **Chair Robertson** shared that he visited the Cemetery recently with Phil Sanders, the City's Facilities Manager. He announced that the City would be paying for the path through the Cemetery to be completely repaved next summer. He suggested that the Commission make an annual budget request to the City of Fairbanks for \$4,000 to cover the cost of concrete bases including delivery and the materials to place the bases each year.

No members objected to the draft correspondence to Public Works requesting annual funding.

f) New Rotary Committee

Chair Robertson stated that in 2010, some members of the Rotary Club were looking for a project to do and that they came up with the idea to build a gate for the Clay Street Cemetery. He shared that the Rotary Club recently formed a new Clay Street committee. **Chair Robertson** shared that both he and Ms. Ripley are members of the new committee and indicated that it will help the Cemetery gain public exposure. He stated that he would like to see a regular column in the News Miner with information about Clay Street and the stories of those buried there. Members spoke briefly to the ease and convenience of using the www.findagrave.com website.

Mr. Turney mentioned that Karen Erickson recently took some kids on a field trip to the Clay Street Cemetery and that Channel 11 covered the story. He stated that Ms. Erickson is nearly finished writing a book about the Cemetery. He commented that he would like to see better signage directing visitors to the Clay Street Cemetery. **Mr. Turney** thanked Phil Sanders for having dirt delivered to the Cemetery to fill the many sinkholes.

The Commission discussed the number of unmarked graves in the Cemetery. **Chair Robertson** commented that bed tax grant dollars may only be used to fund markers in the General sections of the Cemetery. He stated that the other groups are responsible for their own sections.

Ms. Ripley suggested that the Commission try to recruit volunteers from the various groups represented in the Cemetery. She proposed that members of the Commission make presentations to each of the various groups at their regular meetings to try to solicit help or funding for Clay Street.

Mr. Turney spoke to the story of Private John White and mentioned that his gravesite in the Catholic section is in dire need of repair. He commented that he U.S. Army may be willing to help make the repairs.

OPEN AGENDA

Mr. Rex Fisher stated that he paid for a plaque placed in the Cemetery commemorating the Miners. He commented that there was a dedication ceremony for the plaque and that his book about Clay Street also came out about the same time. Mr. Fisher stated that he may be willing to pay for another plaque to be made to commemorate the other Miners. He stated that he has identified many more Miners that died after 1916. He commented that he has created a manuscript of records from 1885 – 1959 of about 1,000 Miners who died of illness or accidents. He stated that he hopes to find a publisher for his new book soon because he has been diagnosed with terminal melanoma. He shared a list of Miners buried in Fairbanks, 24 of which were buried at the Clay Street Cemetery. He expressed hope that the Commission could purchase markers for the 24 individuals. He stated that additional individuals included in the list have records indicating that the bodies were buried at Fairbanks Cemetery, but explained that their names do not appear in Birch Hill or Clay Street burial records. Mr. Fisher shared that he has the last remaining wooden marker from the Old Pioneer Cemetery, belonging to someone by the last name of White. He suggested that new Miners' markers be reproduced to look similar to those original wooden markers and stated that he would be willing to contribute funds to make it happen. He stated that he has formed a trust fund to go towards all the projects that he is interested in and indicated that he would like to get more people from the community involved. Mr. Fisher stated that he will soon be leaving Alaska for the winter to stay at the home in Indiana where 83 years ago he was “bred, born, breastfed, burped and butt-wiped.” He expressed hope that he is around next spring to help with the markers. Mr. Fisher stated that he is willing to help monetarily with the Commission's projects, but that he wants to be included and involved. He stated that he applied to serve on the Clay Street Cemetery Commission when it was formed, but that Mayor Strle did select him for appointment. Mr. Fisher commented on the benefits of placing above-ground markers in the Cemetery. He asked about the new historic sign being placed at the Clay Street Cemetery and suggested that he or Karen Erickson be contacted before it is made so that they can contribute information. Mr. Fisher explained that he has spent many

years researching the history of miners in Alaska and has read every newspaper produced in Alaska prior to its statehood in 1959. He spoke to the hard times in the pipeline days.

Deputy Clerk Snider stated that the new interpretive sign has already been created by the Borough's Historic Preservation Commission as part of their walking tour. She suggested that some of Mr. Fisher's ideas be implemented in the new kiosk that will be built next spring.

Members briefly discussed the location and design of the new kiosk and public access to the Cemetery.

Ms. Ripley stated that she had to leave the meeting early.

Mr. Fisher stated that he has a beautiful color photograph of Irene Sherman, "Queen of Fairbanks," that he would like to see permanently mounted on her gravesite.

Mr. Turney stated that when he gives tours of the Cemetery, Ms. Sherman's gravesite is the first one he shows.

Chair Robertson assured Mr. Fisher that the Commission recognizes financial donors by printing their name on the headstones purchased with their funds.

NEXT MEETING DATE

The next Regular Meeting of the Clay Street Cemetery Commission is scheduled for November 5, 2014.

ADJOURNMENT

Mr. Turney, seconded by **Mr. Erickson**, moved to ADJOURN the meeting.

Chair Robertson called for objection and, hearing none, so ORDERED.

Chair Robertson declared the meeting adjourned at 6:10 P.M.

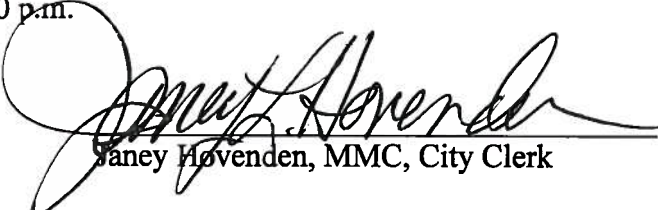

ADJOURNMENT

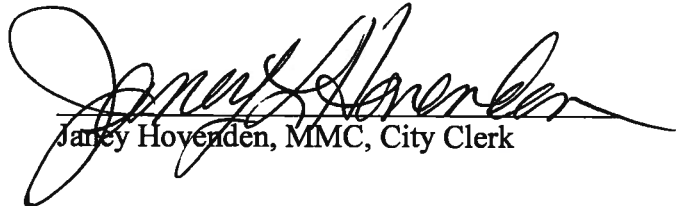

BOARD/COMMISSION CHARACTERISTICS

The Building Code Review and Appeals Commission consists of nine members appointed by the Mayor, subject to confirmation by the City Council, and each member shall serve a five-year term; all terms expire on December 31st of the fifth year. The members of the Commission must reside or work, and have experience with the design or construction of structures within the City. The Building Official shall be an ex officio member of the Commission, who may provide information and recommendations but may not vote on any matter. Two alternate members are appointed by the Mayor, subject to City Council confirmation, to serve in the place of any absent member or otherwise assist the Commission as directed by the chairman.

MEETINGS

Meetings of the Building Code Review and Appeals Commission are called when the subject matter warrants. The chairman is authorized to call meetings, or a majority of the members may require that a meeting be called. All meetings shall be open to the public, except that closed meetings may be held as provided by law. A majority (five members) of the commission shall constitute a quorum and a majority vote of those present and voting shall be necessary to carry any question. Minutes shall be kept as a permanent record of all meetings and shall be filed in the Office of the City Clerk.
